

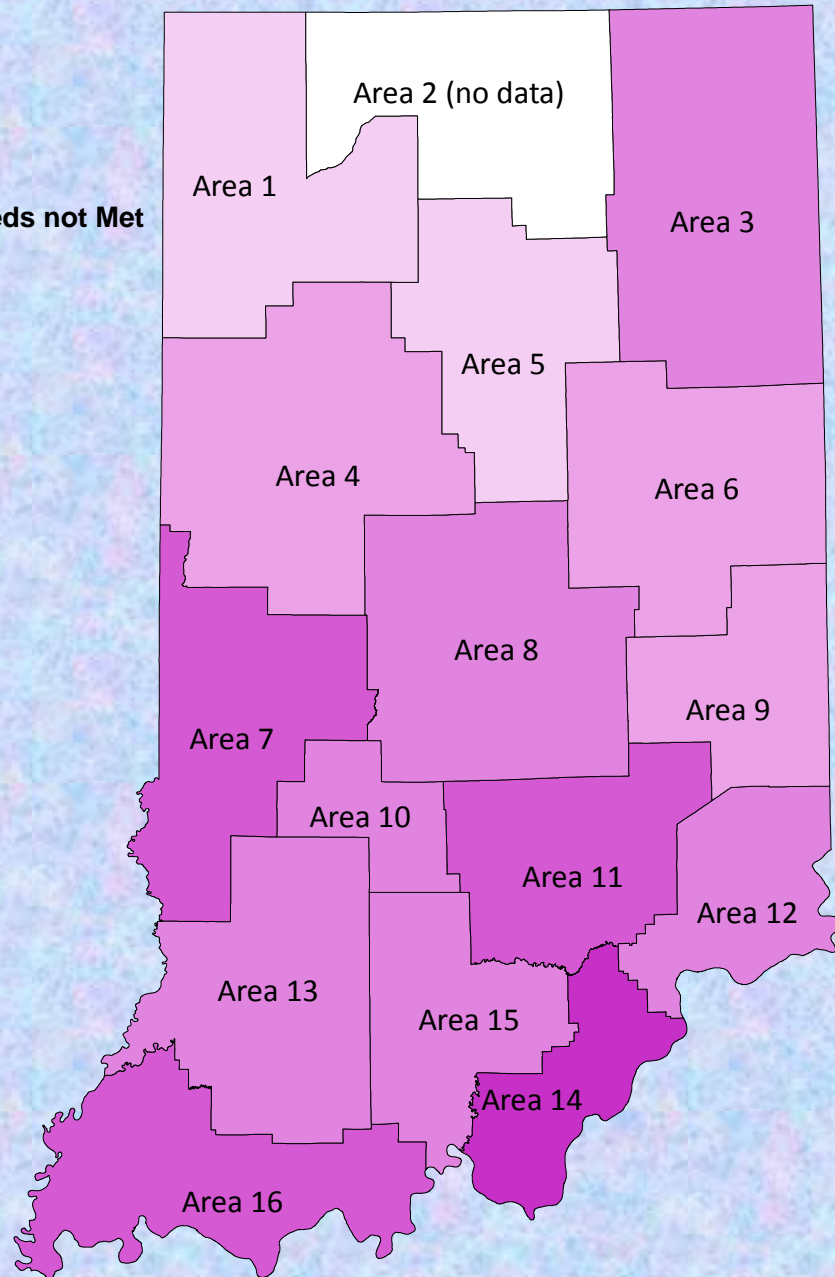

The data provided in this chart are drawn from the *AdvantAge Initiative 2008 Community Survey of Adults Aged 60 and Older*, conducted in 15 service areas and 5 supplemental areas in the state of Indiana - a stratified random digit dial (RDD) telephone survey of a representative sample of 4,969 non-institutional adults aged 60 and older, with sample sizes ranging from 300 to 303 for each Area Agency Region. Area 2 results are not reflected on the chart (including the counties of Elkhart, Kosciusko, LaPorte, Marshall and St. Joseph). The area was surveyed during a different time period (2005) for a different cohort (65+) and, therefore, results are not comparable.
